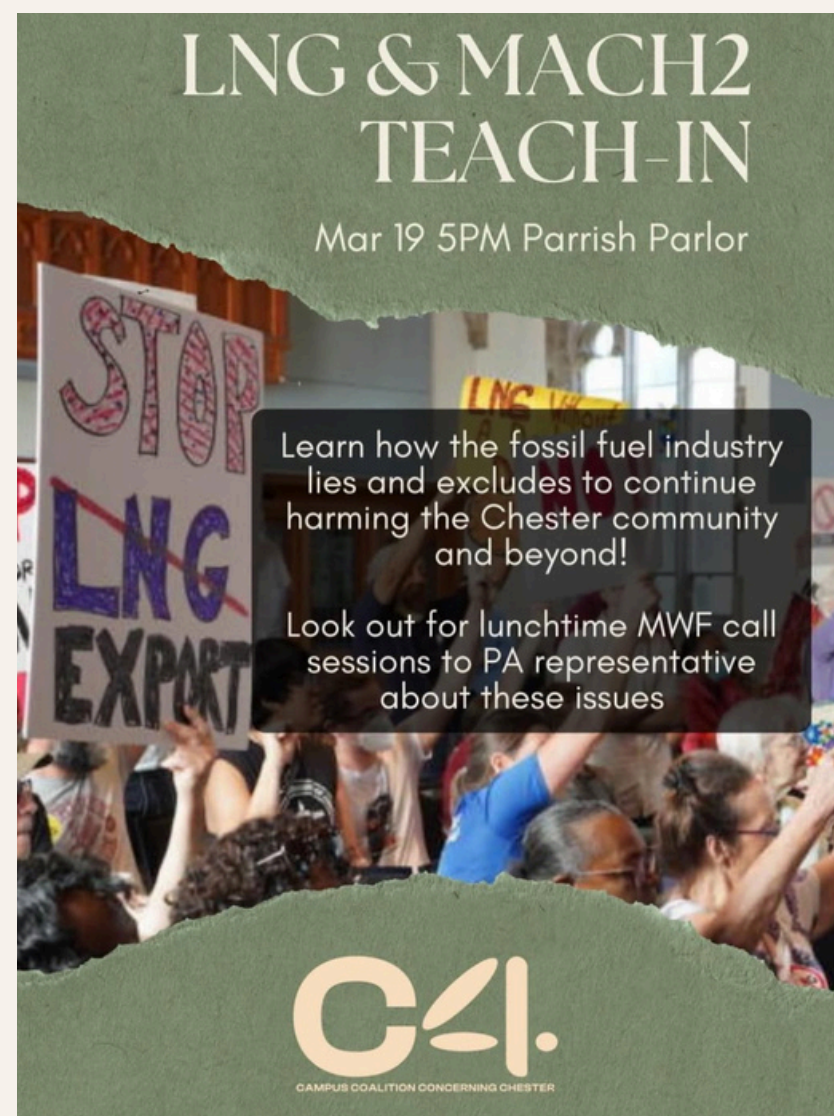


3/19 DCSWA BOARD MEETING

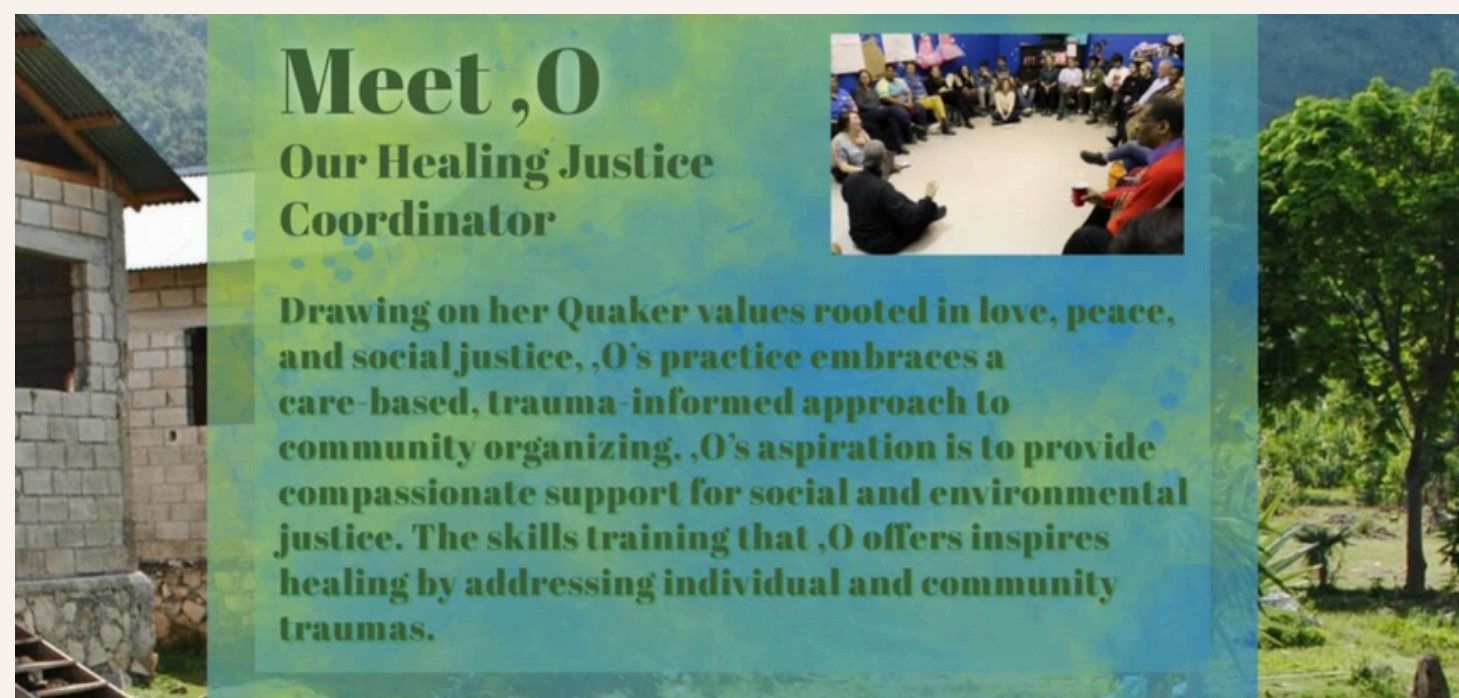
What is LNG? Liquefied natural gas (LNG) is when fracked gas is cooled to a liquid state for transporting, which makes it more explosive and hazardous!!
